

Reading School Governing Body – membership

The Governing Body consists of sixteen governors: two are appointed by the Reading Foundation (the charity which holds in trust the endowments and property of the School), two are elected by staff, and four are elected by parents of students at the School; the Headmaster is *ex officio* a governor; the remaining governors are appointed by the members of the Reading School Academy Trust. A list of current governors (and those who have held office in the past 12 months) is set out below. **All governors, with the exception of the Headmaster, are appointed for 4-year terms of office**
